New/Open Order Confirmation

 - No (3)Commit if you leave promise qty and date fields empty
- After **Acknowledging**, update the Promise Quantity and/or Confirmed Arrival Date/Confirmed Ship Date if needed and the Discrete Order State transitions into Accepted **OR** Accepted w/Changes (in case promise qty and/or date is different from Jabil requested qty and date!)
- After you populate No Commit, Discrete Order status transitions into No Commit





PO Acknowledge

- New and Open PO details are available in the table embedded into the email body text
